Note about the casue of death of Dr. Kodela Siva Prasada Rao :-

After 2019 General Elections and after YSR Congress Party came into power, within span of two months, as many as nineteen (19) criminal cases were registered in Narsaraopet and in Sattenapalli against family members of Dr.Kodela Siva Prasadarao. These cases were registered against his son Dr.Sivaram, his daughter Dr.Vijayalakshmi and himself.

Crime No.136/2019 of Sattenapally Rural P.S for the alleged offences under section 420 IPC (Cheating).

Crime No.149/2019 of Sattenapally Town P.S for the alleged offences under section 420 IPC (Cheating)

Crime No.153/2019 of Narsaraopet 1town P.S for the alleged offences under section 420, 506 r/w 34 IPC and under SC& ST (POA) Act.

Crime No.163/2019 of Narsaraopet 1Town P.S for the alleged offences under section 384, 506 r/w 34 IPC (Extortion).

Crime No.164/2019 of Narsaraopet-II Town P.S for the alleged offences under section 420, 323, 506 r/w 34 IPC (Cheating).

Crime No.169/2019 of Narsaraopet II Town P.S for the alleged offences under section 420,468,472, 477, 387 r/w 34 IPC (Cheating and Forgery).

Crime No.172/2019 of Narsaraopet 1Town P.S for the alleged offences under section 447,506 and 109 r/w 34 IPC (Tress-pass).

Crime No.231/2019 of Narsaraopet Rural P.S for the alleged offences under section 354, 384,323, 447. 506 r/w 34 IPC (Tress-pass, Extortion, molestation).

Crime No.235/2019 of Narsaraopet Rural P.S for the alleged offences under section 384,323, 506, 509 r/w 34 IPC and under SC & ST(POA) Act (Extortion, causing simple hurt and abuse naming the caste).

Crime No.238/2019 of Narsaraopet Rural P.S for the alleged offences under section 384, 506 r/w 34 IPC (Extortion).

Crime No.244/2019 of Thullur P.S for the alleged offences under section 409 & 411 IPC (Criminal breach of trust and Assembly Furniture).

Crime No.245 /2019 of Narsaraopet Rural P.S for the alleged offences under section 384, 323, 506 r/w 34 IPC (Extortion).

In all the cases, the offences said to have been committed in the year 2016, 2017 and 2018. In respect of any case, no date offence was mentioned. All are registered basing on vague, baseless and unfounded allegations. There is abnormal delay in lodging the reports.

Giving a go by to the principles of law laid down by the Supreme Court and contrary to the procedure prescribed in the criminal procedure code, these crimes are registered and put all the family members under threat of arrest.

When there is an abnormal delay in lodging report, the police shall not register the crime without conducting preliminary enquiry. In no case preliminary enquiry was conducted. When the allegation of committing offence said to have occurred long back and no particulars of date and place are given, police shall not register the crime mechanically affecting rights of the accused.

After YSR Congress Party came into power, Mr.Vijaysai Reddy went on twittering repeatedly asking people of Narsaraopet and Sattenapally to lodge complaints against family members of Dr.Kodela. Mr.vijaysai Reddy further stated that if persons would come forward to lodge police report, he would take care of them. After such twitters, all these crimes are registered. Mr.Y.S.Jagan Mohan Reddy, before elections, made orchestrated propaganda against family members of Dr.Kodela.

Sakshi daily and Sakshi news channel which are owned by Mr.Y.S.Jagan Mohan Reddy, have been regularly publishing news items and propagating and telecasting the news against family members of Dr.Kodela and defaming them. All FIRs consists of stereo type allegation and narrations. Mr.Gopireddy Srinivasa Reddy M.L.A of Narsaraopet with active support of Mr.Vijaysai Reddy and Y.S.Jagan Mohan Reddy, organized certain likeminded people, prepared reports in his back yards and got such reports registered as crimes against family members of Dr.Kodela. Unless there is an influence from MLA of Narsaraopet, no police officer shall register such crimes. Sub Divisional Police Officers of Narsaraopet and Sattenapally Sub-Divisions have been identifying with the said MLA and acting in-tune with his directions.

Team of Advocates from Narsaraopet approached DSP Narsaraopet and requested to follow the procedure contemplated under sections 41 and 41A Cr.P.C (granting of station bail) as alleged offences are of long back and maximum punishment prescribed is up to three years. The DSP stated them that he would not grant station bail and further he went on scolding with vulgar language the family Dr.Kodela. when Dr.Kodela personally members of approached the Superintendent of Police, Guntur Rural requested her to direct the sub-ordinate police officers to follow station bail procedures, she showed deaf hear and did not even extend respect. He personally contacted DGP Mr.Shawang who expressed helplessness in view of involvement of Mr. Vijaya Sai Reddy and Hon'ble Chief Minister.

Dr.Kodela was humiliated with the way how the crimes are registered and how the police personal are acting and behaving in-tune with the persons of party in power.

These following are few examples:

One Budumuru Naga Raju, Ranzi Cricketer lodged report alleging that Dr.Sivaram S/o.Dr.Kodela promised to secure job in Railways and collected money and failed to secure the job. She further alleged that then it was brought to the notice of Dr.Kodela, he did not respond. Basing on the such allegations, police registered crime of cheating against Dr.Sivaram and Dr.Kodela. Mr.Naga Raju is a notorious criminal and an unsocial element. Sakshi daily and news channel made gobel propaganda about these allegations and made the people to believe such allegations.

Another example is that one Kandukuri Buchi Venkayamma lodged a complaint alleging that in the year 2016, her brother in-laws sold away 1½ cents of land belongs to her son and further alleging that her brother in laws are followers of son of Dr.Kodela and further alleged that when it was brought to the notice of the son and the daughter of Dr.Kodela, they supported brother-in-laws. This compliant was registered as crime against daughter and son of Dr.Kodela without looking into whether it is a civil dispute or not whether Venkayamma has locus to complain or not.

One Ravi lodged a report alleging that when he went to guest house at Narsaraopet to meet Dr. Sivaram who in turn scolded Mr.Ravi naming caste. This complaint was readily registered as crime for the alleged offences under section 420 and SC & ST(POA) Act without minimum verification of facts.. The fact remains that Dr. Sivaram was in abroad as on the date of alleged incident said to have occurred at Narsaraopet. Mr.Ravi had already been in jail on the allegation of committing cheating promising jobs.

After the Legislative Assembly was shifted from Hyderabad to Amaravathi, the CRDA provided furniture for the assembly. The furniture brought from Hyderabad kept idle and there was space constraint. The care taker of furniture kept some of the furniture at the residential house and camp offices of the speaker for safety. The speaker was no way concerned with the furniture. Immediately after formation of new government and assembly, Dr.Kodela contacted the Secretary of Assembly and informed to take back the furniture who in turn advised that if Dr.Kodela was willing to pay the costs of the furniture, he would send proposals. Immediately, thereafter. Dr.Kodela wrote a letter to the Secretary and also remainders to Hon'ble Speaker requesting to assess the value so that he would in reposition to pay the amount. Since there was no response Dr.Kodela filed Writ Petition before Hon'ble High Court of A.P seeking a direction to the Secretary to take back the furniture. This writ petition is pending.

While matter stood thus, Mr.Gopireddy Srinivasa Reddy MLA lodged complaint to the secretary on 22.8.2019 alleging misuse of assembly furniture by Dr.Kodela. The Sakshi daily and Sakshi news channel propagated as if Dr.Kodela took away valuable furniture of the Assembly. Basing on the such complaint, the Thasildhar and Assembly Staff entered into the camp premises of Dr.Kodela without prior intimation, permission and knowledge and seized the furniture and released photos of furniture to media on 23.8.2019. On very next day i.e 24.8.2019, the Secretary lodged report to SHO Thullur P.S who readily registered the crime under section 409 and 411 IPC (criminal breach of trust). The punishment prescribed under section 409 IPC is up to Life Imprisonment.

This crime was registered against Dr.Kodela as if he was a public servant, he was entrusted with the property and he misappropriated the property of assembly and thereby committed theft. The Secretary intentionally kept aside the letters submitted by Dr.Kodela and acted on basing the complaint lodged by the MLA.

Sakshi daily and the News channel went on tagging Dr.Kodela for each and every unconnected issues for example one Juvaadi Srinivasa Rao is working as Senior Assistant in Acharya Nagarjuna University. Few days back he was taken into task by ACB on the allegation of disproportionate assets. Sakshi daily published an news item propagating that this Srinivasarao acquired properties with the support of Dr.Kodela who does not know about Srinivasarao. The only reason would be that Mr.Srinivasarao belongs to a same social group (caste) of Dr.Kodela and he is from one of the Villages of Narsaraopet Constituency. For Sakshi this allegation is sufficient to tag any one to unconnected issues.

Siva PrasadaRao and no furniture is there in the said room.Entire verification for furniture has been conducted by our staff under video coverage and by preparing a panchanama signed by all the officials present at the time of verification. The furniture found in the building is pertaining to the Office of Hon'ble Speaker, AP. Assembly at Hyderabad before shifting it to Amaravathi. It was shifted
